**PARENT NOTIFICATION AND AGREEMENT.** As the parent/guardian of the above named player, I intend to register this player with this Club for the 2019 season as stipulated in this Letter of Intent. I agree to pay all fees as described below in full:

The fee for the 2019 season is \$1,325.00 for returning players and \$1,520.00 for new players. The season fee is based upon expenses for practices, games, tournaments, leagues, club registration fees, coaches stipends, administrative fees, team equipment and space rental for facilities. Players new to the Club need to pay a one-time registration fee of \$195.00 which includes uniform, club t-shirt, tank top and player insurance.

Payments can be made in one full installment of \$1325.00 (\$50 deducted for tryouts) for returning players and \$1,520.00 (\$50 deducted for tryouts) for new players by March 27, 2019. San Diego Sol will accept monthly payments as follows (there is a \$45 charge for returning players and a \$60 charge for new players to use the payment plan):

**If you choose the payment plan please write three checks – one for March 27, April 27 and May 27 and turn them in at the parent meeting.** It is the policy of the Club that no participant will be permitted to compete where an account carries an overdue balance. *Payments received 10 days after the payment is due will be charged a \$15 late fee.*

The obligation to pay fees for the entire club season is unconditional. Club Fees will not be prorated for partial month's participation. Any failure to pay the fees for the entire season will result in damages to the San Diego Sol Basketball Club. No portion of the season fee so paid or outstanding will be refunded or canceled, notwithstanding the subsequent withdrawal of the athlete for relocation, injury or illness.

The enrollment shall be accepted and the reservation entered upon execution of this Agreement and upon payment of the first month's fees. These fees are nonrefundable.

This Agreement shall not be modified except by written agreement between the parties. Each parent or guardian shall sign this Agreement and will be jointly and severally responsible for the obligations contained herein.

This Agreement shall be deemed to have been entered into in the State of California and its validity, effect and operation shall be determined in accordance with the provisions of California law.

In the event any provision of this AGREEMENT is found to be or is deemed unenforceable, such shall not affect the enforceability of any other provision herein. If any provision or portion of this AGREEMENT is held to be illegal or invalid by a Court, said provisions shall be deemed to be severed and deleted, and the remainder of this AGREEMENT shall continue to be valid and enforceable.
